  2. By deleting the amount “\$4.50” appearing in clause 18.3(a)(ii) and inserting “\$4.85”.
  3. By deleting the amount “\$17.03” appearing in clause 18.3(a)(iii) and inserting “\$18.36”.
  4. By deleting the amount “\$21.31” appearing in clause 18.3(a)(iv) and inserting “\$22.98”.
  5. By deleting the amount “\$0.92” appearing in clause 18.3(b)(ii) and inserting “\$0.96”.
  6. By deleting the table appearing in clause 18.3(c)(iii) and inserting the following:

7. By deleting the amount “\$23.89” appearing in clause 18.3(c)(vi) and inserting “\$29.86”.

9. By deleting the table appearing in clause C.2 and inserting the following:
