We refer to the above matter and the current directions dated 27 June 2023 (**Directions**).

The Directions currently provide for Apple to send a notification to Apple employees' email addresses where those employees are covered by the *Apple Retail Enterprise Agreement 2014*, by 9 August 2023, to invite them to share their views on the termination application with the President.

The purpose of this email is to seek a variation to the Directions, by consent with the Applicant.

Reason for proposed variation

At the time that the Directions were made, it was not anticipated that the timing of this process would coincide with the access period.

We are instructed that the ballot for the proposed enterprise agreement will open at 9 am on Friday 11 August 2023 and that the results of the vote will be known by soon after 5 pm on Sunday, 13 August 2023 when voting closes. Employees were notified yesterday of the upcoming vote and access period.

We submit it is appropriate to seek a variation to the Directions for the following reasons:

1. **Potential to create confusion:** in our view, there is a very real prospect that having the two processes run in unison will create confusion for affected employees
2. **Potentially impact of vote on termination application:** the outcome of the vote on the NEA has the potential to render the termination application redundant

Impact of the proposed variation on the hearing dates

In our respectful submission, the proposed variation would not impact on the hearing which is due to commence on 30 August 2023.

Although we accept the period for employee views will be shorter, it remains that employees were initially invited to provide their views on the termination application, albeit in the absence of the now filed materials, in accordance with earlier directions made on 25 January 2023.

The proposed variation still provides the parties, as well as the Commission, two clear business days between the end of the period to provide employee views and the commencement of the hearing.

Variation sought

We seek, by consent with the Applicant, the following amendments to the Directions:

1. By 4:00 pm on ~~Wednesday, 9~~ Tuesday 15 August 2023 Apple Pty Limited t/a Apple is to serve by email a copy of:

- a) these directions;
 - b) the originating application (Form F24B) (Application) lodged on 23 December 2022;
 - c) the declaration in relation to termination of an enterprise agreement after the nominal expiry date (Form F24C) dated 23 December 2022; and
 - d) a link to the Commission's webpage for this matter.
- (together, the application documents)

on each employee covered by the Apple Retail Enterprise Agreement 2014 (Agreement) and invite them to provide their views on the Application pursuant to s 226(3)(a) of the Fair Work Act 2009 (Cth) in accordance with item 3 of these directions below.

2. By 4:00 pm on ~~Friday, 11~~ Wednesday 16 August 2023, a director or authorised officer of Apple is to file a statutory declaration confirming compliance with item 1 of these directions.

3. By 4:00 pm on ~~Wednesday, 23~~ Friday 25 August 2023, any employee covered by the Agreement may provide their views on the Application, by sending an email to chambers.hatcher.j@fwc.gov.au.

We respectfully request that the Directions are varied as sought in chambers.

The Applicants' representatives, and the SDA and Mr Murtagh, are copied to this email.
