Dear Associate to Deputy President Hamberger.

I refer to the notice of listing of 25 May 2017 which provides for hearing of substantive matters on 6 and 7 June. I also refer to the Amended Directions of 7 April 2017 which extended the period for filing of evidence in substantive matters to 14 April and a reply on 2 June.

The CPSU filed a materials for a substantive variation to the BREA on 7 April, including 3 witness statements. In earlier conferences the Deputy President had suggested once material had been filed there may be programming of the hearing days.

The CPSU requests further consideration be given to programming of those two hearing days. This will allow the CPSU to make its witness available at that time and allow other parties with no interest in our variation be programmed at another part of the hearing.
