Subject: AM2018/18 and AM2018/20: Final Submissions

Dear Associate,

The IEU, UV and the employer parties have conferred on how to best proceed with final submissions on Friday, 9 August 2019, given the number of claims involved.

Subject to the Bench's view, the parties propose the following approach:

1. IEU submissions re: its claims – interested parties reply – IEU reply;
2. ACA submissions re: its claims – interested parties reply – ACA reply; and
3. UV submissions re: its claims – interested parties reply – UV reply.

The claims of Elizabeth and Isabelle Arrabalde will also need to be included. Subject to their views, given the overlap with UV claims it would appear sensible to deal with the individual claims in the same manner before or after UV.

This will ensure each claim, and reply, is dealt with in full in an orderly manner. It will also permit parties who do not wish to be heard in respect of certain claims, to (if appropriate and with the Bench's leave) excuse themselves.
