On the 29 January 2020, the President issued a Statement [2020] FWC 421 which included a timeline for submissions and submissions in reply regarding exposure drafts and draft variation determinations including for the Aircraft Cabin Crew Award 2010 issued on 29 January 2020. The timeline indicated a deadline for parties to provide comment on the Exposure Drafts by 4 March 2020.

A number of matters have recently arisen preventing the FAAA from being able to conclude its review of the Exposure Draft and provide comment. During the last 2 weeks the FAAA has experienced staff turnover. We are currently reassigning matters and interviewing for several
