Re.: AM2018/9 - Application to vary Education Services (Teachers) Award 2020 on work value grounds – further s602 correction sought to Draft Determination

We refer to the above-mentioned matter, paragraph [85] of the Full Bench's decision in [2021] FWCFB 6021 and our further submissions of 21 October 2021 and 26 October 2021.

A further drafting issue that should be corrected was brought to our attention late yesterday - that is the inconsistency between the proposed clause 14.1 [paragraph 8 of Draft Determination] and the table in clause 17.1 [paragraph 9 of Draft Determination].

Currently the criteria for progression are not incorporated into the existing clause 17.1. In introducing the criteria into clause 17.1, it appears that an earlier proposed version of the criteria has been inadvertently used, rather than the criteria contained in the new clause 14.1.

The IEU seeks, pursuant to s.602 of the Fair Work Act, that the Criteria contained in the new clause 14.1 be replicated in the new clause 17.1 to ensure a consistent approach and give full effect to the Full Bench's decision of 11 October 2021.

Apologies to the Commission and the other parties for the late notification of this correction.
