We confirm that the ANMF has had discussions with the other parties to attempt to narrow the further issues to be determined in Stage 3. The extent of agreement between the parties is reflected in Background Document 10 and the parties' responses to that document.

The ANMF proposes with the consent of the UWU, AWU and ASU that Stage 3 be progressed in the following tranches:

- (a) Further evidence about indirect care workers
- (b) Evidence about COVID-19, staffing and other matters relevant to wage adjustments in excess of 15% for direct care workers
- (c) Evidence about award and classification structures
- (d) Submissions

The ANMF proposes with the consent of the UWU, AWU and ASU that a conference be listed for the purpose of the parties seeking directions from the Commission at least in respect of the first tranche referred to above.
