Dear Associate,

We refer to paragraphs [1](4) and [1](5) of the directions issued by the Commission dated 13 January 2023 (**the Directions**).

The parties have conferred in relation to the Directions and, by consent, the HSU respectfully requests that the time for complying with the Directions be extended to 5pm on 7 March 2023 for all parties.

This request is made on the basis that:

1. it will allow further discussions between the parties in an attempt to narrow the issues to be determined in Stage 3 of the Proceedings; and
2. it will resolve difficulties for the Commonwealth arising from the unavailability late this week and early next week of Ministers with authority to provide final instructions on the Commonwealth's position on these matters.

We can indicate that a number of parties have met in relation to the issues raised in Background Paper 10 already and that further meetings have been arranged for next week.

We thank the Commission in advance for the consideration of this application for an extension for all parties.

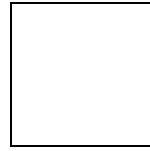
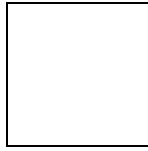
