5. By deleting the amounts “\$169.51” and “\$451.14” appearing in clause 17.3(d)(iii) and inserting “\$176.91” and “\$470.84” respectively.
6. By deleting the amount “\$451.14” appearing in clause 17.3(e)(i) and inserting “\$470.84”.
7. By deleting the table appearing in clause 17.3(e)(ii) and inserting the following:
