4. By deleting the amount "\$20.50" appearing in clause 18.3(a)(iv) and inserting "\$20.83".
5. By deleting the table appearing in clause 18.3(c)(iii) and inserting the following:

6. By deleting the amount "\$21.99" appearing in clause 18.3(c)(vi) and inserting "\$22.84".
